PROGRAM REPORTS

Eric Nichols gave an overview for **Instructional Support and Technology**.

Mr. Nichols talked about the upcoming annual Tech conference. He said it would be the seventh year having it, and this year it would be held at HESD which he said he is very excited about. Eric said he would have two speakers that he considers two of the best in the world; Alice Keeler and Eric Curts. He is expecting about 80 attendees with 25-40 of those being students. Eric said this is a great opportunity for student voice.

Donna Schnitker submitted the program reports for **Early Childhood and Special Education** to the Board which can be found in the board packet.

Donna Shnitker said the Head Start program is fully enrolled and they have a waitlist. Donna said they submitted their continuation grant for the Head-Start program and it included their new slots for extended day. She stated they went from receiving \$200,000 from federal Head Start to receiving \$364,000 per year. Donna said they will need to hire a few more employees for next year because of the change in model and that some staff are leaving. She said they will need to hire three teachers, one home-base home visitor and three assistants.

EI/ECSE is currently serving 40 children.

Great Start is fully enrolled and has remained so all year. Donna said this class has a large number of children enrolling now and expect to have a waiting list.

Donna said the Frontier Hub will have a monitoring visit on April 25th.
