### **PROGRAM REPORTS**

Donna Schnitker submitted the program reports for **Early Childhood and Special Education** to the Board which can be found in the board packet.

Donna Shnitker said the Head Start is closed for the summer as of June 5<sup>th</sup>. Donna prasied her staff with how amazing they did throughout the pandemic. She talked about what they were able to do for the children regarding graduation and said it all turned out wonderful and the parents and children

really enjoyed it.

Donna said they have everything in place to provide summer school for 30 students. This will allow for three classes of 10 students. These classes will be Mondays and Wednesdays from 9-12. Donna said they will be following all rules and requirements regarding cleaning and sanitization given by the state. She said one thing that will be new is the state is requiring the children to have their temperatures taken before they enter the building.

The Early Learning Division has postponed awarding any of the grants for our programs until the Division can be certain of the dollars available to fund them. Donna said they have delayed this until July  $1^{st}$ .

EI/ECSE is currently at 44 children with more referrals coming in. Donna said they have more evaluations scheduled in the coming week.

Donna said Head Start ended with a very cute graduation and was very happy with all her staff.

Donna said the Frontier Hub is in a holding pattern while funding for coordinated enrollment is being figured out.

### **Superintendent Report**

#### **SSA Comprehensive Support Plan**

Superintendent Criss discussed the SIA Funds and said they are currently predicting a 40% reduction of funds. They are hoping to get final numbers in July. Superintendent Criss talked about the SIA Administrator position and said we can't post the position until we know the position is secure,

#### **Safety Report**

There were no incidents reported. Discussion was had regarding updates on COVID 19. Superintendent Criss told the board that she received a new 47-page guidance document for reopening schools in the Fall called Ready Schools, Safe Learners. Superintendent Criss highlighted areas of the 47-page document, discussion followed.

### **Late Additions**

Superintendent Criss told the board that the Bond Measure that School District #3 is going for will be up for voting in November and said she had discussed with Superintendent Quick that Harney ESD would be supporting them in this.
