Donna said Head Start classes are going well and have 74 children currently enrolled. She said they get more applications weekly and are confident Head Start will be fully enrolled.

EI/ESCE has 31 children currently enrolled with new referrals coming in weekly. Mrs. Shnitker said Courtney is screening all of the new children at ECC and has several that need to be referred for evaluation.

Preschool Promise is fully operational which Mrs. Shnitker said is the only one fully operational in the State. She said the classes are going really well.

The Frontier Hub is still working on coordinated enrollment. Child Care Resource and Referral (CC&R) is a new program that will being in January 2021. This will increase staffing by two people with the goal of increasing the number of childcare placements in the community.

### **Superintendent Report**

Superintendent Criss shared the flyer for OSBA Board Member & Secretary/Clerk Training October 28<sup>th</sup> 4:00PM-7:30PM with the board members. She said currently there are two board members that have RSVP'd and said Hollie would be contacting Board Clerks and Board Chairs to see if we could get more board members to attend. Hollie told the board if they have any material or questions they would like to have covered in the training to let her know so she could get with OSBA to have the trainings tailored more to those requests.

The Local Service Plan Meeting will be held October 22<sup>nd</sup> from 3:30PM-5:00PM and will be available inperson and virtually.

Superintendent Criss recognized Business Manager Cori Wright on an outstanding job with her work on the Audit last week. She said Cori has done a phenomenal job. The board thanked Cori for her hard work.

Superintendent Criss discussed policy KBA and KBA-AR with the board regarding Records requests and charges for those requests.

Mrs. Criss gave kudos to Donna and her staff at the Early Childhood Center on the great work and revamping they have done on the old Filmore building. She said it looks great.
