PROGRAM REPORTS

Donna Schnitker submitted the program reports for **Early Childhood and Special Education** to the Board which can be found in the board packet.

Donna Shnitker highlighted the programs report for Early Childhood and Special Education.

Donna said Head Start began in person classes on August 31st and said it was very successful. As of right now they have only 4 slots unfilled. Donna said the children and parents are so happy to be back in school. She said parents are not allowed to come in the buildings right now because of COVID so kids were dropped off at the door. She said some of the children had a hard time with this, but for the most part they all did great.

EI/ESCE has 29 children enrolled as 17 children went into Kindergarten this year. They continue to get more referrals from doctors for children under three and they have not begun their screening process at the center, so they are expecting to have more children on their caseload.

Preschool Promise began the same time as Head Start and it went great as well. They have moved this class to the old Fillmore building and used start up dollars to put in new windows which she said has drastically improved the look of the classroom.

The Frontier Hub is still working on coordinated enrollment. Donna said they have also tried a virtual parenting class and had eight parents and completed the courses. She said the parents really liked the option of it being available virtually.

Superintendent Report

Superintendent Criss talked about being able to visit each of the Rural schools as they had their first weeks of school and said how wonderful it was and how excited was to see the children and teachers back in school for in person learning. She gave Kudos to the staff and teachers for working so hard to make that happen.

This year Harney ESD will not be able to hold the annual health fair due to COVID-19, but said each of the screeners with be going out to each rural school one by one this year.

Superintendent Criss said the board will be getting a survey on board member learning activities.

With the new executive order board meetings are now allowed in person. October's meeting with be held at Harney ESD and will be available virtually for those who do not feel comfortable joining in person.

It was asked that the November board meeting be changed to Tuesday Nov. 10th due to the regularly scheduled Wednesday being a holiday. It was agreed and has been set for Tuesday Nov. 10th
